WAR MEMORIAL BOARD OF TRUSTEES
REGULAR MONTHLY MEETING

Thursday, December 11, 2008

The Board of Trustees of the War Memorial of San Francisco met in special session at 2:00 p.m. on Thursday, December 11, 2008, in the Trustees' Board Room, 4th Floor, War Memorial Opera House, President Horn presiding.

APPROVAL OF MINUTES

President Horn called for approval of the minutes of the November 20, 2008 special meeting of the Board. On motion of Trustee Moscone, seconded by Trustee Davis, the minutes were unanimously approved.

PRESIDENT'S REPORT

Opera and Ballet Seasons: President Horn stated that the San Francisco Opera concluded the fall portion of its 2008-09 Season on December 7th, and he extended congratulations to the Opera on a superb season. He stated that the San Francisco Ballet opens its 2008 *Nutcracker* Season in the Opera House this evening, and will present 31 performances through December 28. On behalf of the Board, President Horn extended best wishes to the Ballet for a successful *Nutcracker* Season.

War Memorial Budget for FY 2009-10: President Horn reported that City department budget requests for the 2009-2010 fiscal year must be submitted to the Controller and the Mayor on February 20, 2009. He stated that in order to meet this deadline, the Board must consider and approve the War Memorial's FY 2009-10 budget request at the February 12, 2009 meeting. President Horn referred this matter to the Board's Budget and Finance Committee and asked the Committee to meet during the next two months and provide recommendations to the full Board at the February meeting.

RESOLVED, That this Board unanimously elects Charlotte M. Shultz as its Vice President for 2009.
