

**MINUTES**  
**WAR MEMORIAL BOARD OF TRUSTEES**  
**REGULAR MONTHLY MEETING**

**Thursday, January 9, 2003**

The Board of Trustees of the War Memorial of San Francisco met in regular session at 2:00 p.m. on Thursday, January 9, 2003, in the Trustees' Board Room, War Memorial Opera House, President Jarman presiding.

**ROLL CALL**

**APPROVAL OF MINUTES**

President Jarman called for approval of the minutes of the December 12, 2002 regular meeting of the Board. On motion of Trustee Farrow, seconded by Trustee Leones, the minutes were unanimously approved.

**PRESIDENT'S REPORT**

**Opening of Ballet Repertory Season:** President Jarman reported that the San Francisco Ballet will open its 2003 Repertory Season on January 29, with a special performance in the Opera House and opening night festivities at City Hall. On behalf of the Board, President Jarman extended best wishes to the Ballet for a successful 2003 Season.
